**FURTHER RESOLVED**, that the proper officers and agents of the Mortgage Lender designated herein be, and each of them hereby is, authorized, jointly and severally, to take any and all steps, do any and all things and execute and deliver any and all documents, including amendments thereto, in the name and on behalf of the Mortgage Lender as may be necessary or appropriate to carry out the purpose of the foregoing resolutions and to perform the obligations of the Mortgage Lender under the Program Agreement.
